Project: Addition of Gender neutral toilets trial at Tramway

b) List main outcome focus and supporting activities of the Policy, Project, Service Reform or Budget Option

The main outcome for this project is equality of access to toilet facilities for all Tramway users.

Tramway is an international art space, hosting the work of emerging artists who focus on contemporary visual art and contemporary performance and dance. It is operated by Glasgow Life within the Arts & Music service.

Following numerous requests, over the past few years, Tramway created temporary gender neutral toilet signage and, in addition to retaining traditionally assigned facilities, has used this on occasions at the request of artist and organisations such as during Arika's festivals, LGBYTQ events and from individual artists. See Appendix 2.

There are toilets allocated on all three floors of the venue and the trail involved:

- a) Gender neutral toilets assigned to the ground floor
- b) Toilets on the mezzanine level being assigned according to the performance/exhibition and audience demand to either being gender neutral or specific male or female
- c) Toilets on the third level being traditional male and female provision

In addition to this there are accessible toilets on each level and baby changing facilities.

Due to the success of these trials, a longer term trial followed between July and December 2018. The trial arrangement remains in place pending a future decision on whether gender neutral toilets (sometimes known as all gender toilets) are to become standard provision at Tramway, alongside retention of traditionally assigned facilities.

APPENDIX 1

TRAMWAY

Gender Neutral Toilet Trial Report 2019

Tramway is an international art space supporting emerging artists who focus on experimental contemporary visual art, performance and dance and supporting the wider sector. Tramway offers an inclusive service and supports all people to be able to use a toilet of their choice without stress, fear or anxiety.

Tramway introduced temporary signage on some toilets, while also retaining separate male and female-only toilets, upon the request of festival/event producers and this was met with much positive feedback from audiences. A longer trial was put in place from July to December 2018: maintaining male and female-only toilets and adding signage to some toilets to identify the facilities (i.e. urinals and stalls). This offered individuals a choice of facility not defined by traditional gender norms.

Initially these non-gender identified toilets/gender neutral toilets were introduced specifically for transgender, including non-binary people and feedback received is clear in the need for this: the majority of Tramway customers want toilets that are both functional and meet the needs of society rather than based upon a judgement of a person's physical presentation as a male or female. As such the toilets that are identified by their facility (i.e. urinals and stalls) are now accessible for all people, whether transgender, non-binary, male or female.

During the trial period there were **107,531** visitors to Tramway who were provided with the choice to use the male or female-only, accessible and gender neutral signed facilities according to their personal wishes.

As well as supporting transgender, including non-binary people it became clear that there were other groups benefiting: parents of any gender could take children of any gender to the toilets without urinals. Similarly groups of people supporting special needs children and adults were able to go as a group to the toilets, making their venue visit a more inclusive experience.

In order to inform the trial Tramway gathered feedback, offered questionnaires and observed behaviour within the venue, as well as liaising with equality organisations, collecting desk base research and liaising with the growing group of theatre and visual arts centres introducing gender neutral toilet provision. As part of this work the Equality Network said: "We welcome Tramway's decision to their gender neutral toilets. Having a range of different facilities will allow Tramway to be best able to meet the diverse needs of its audiences, and ensures that everyone is able, confident and comfortable using the toilet".

One of the main pieces of research on UK toilet spaces: Around the Toilet, influenced this transgender and non-binary inclusive approach to toilet facilities in Tramway. This research project took place between April 2015 and February 2018 involving the public, artists, urban

planners and architects. The main findings mirror the public feedback at Tramway: the 'one size fits all' approach to toilet design doesn't work, there is a need for gender neutral provision to benefit a range of people (including: parents with children of a different gender; those who care for people of a different gender; some disabled people who have a personal assistant of a different gender; and some people whose gender is questioned in the toilet, including some

trans and non- binary people), many trans and non-binary people experience harassment and violence in binary gendered toilets and finally to broaden public attitudes and ways of understanding toilet spaces and our fellow occupants.

The feedback from audience members and artists was overwhelmingly in favour of retaining gender neutral toilets amongst the range of provision: There were **189** written surveys received of which **178** agreed with the gender neutral provision and **19** written formal complaints received.

The themes of the feedback in favour of offering gender neutral provision focused on:

- upholding civil rights
- offering audience preferences/choice,
- creating an open and safe environment
- reducing vulnerability for trans and non-binary people
- eliminating harassment, bullying and intimidation, (with examples provided of peoples experiences).

The complaints received focused on themes including:

- sanitary bin provision (not being in all gender neutral assigned toilets)
- concerns about impacts on ethnic female communities
- questioning the needs of transgender and non-binary people
- perceptions of safety issues based upon individuals previous experiences of male violence in other contexts.

The outcome is that the gender neutral toilets are recommended to remain in place subject to the following conditions:

- An equality impact assessment that does not demonstrate a high level of negative impact or breach of equality legislation, and that mitigation action is taken on any impact highlighted in the assessment
- Some work being done to help inform visitors and users of the building of Tramway's commitment to inclusion.
- Alongside gender neutral provision, that the accessible, male and female-only toilets and baby changing facilities would also remain in place.
- That the mezzanine level toilets are used flexibly – either gender neutral or solely male/female dependent upon particular audience needs
